## **RESOLUTION NO. 313-2023**

**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO CONTRACT WITH THE WINNING BIDDER FOR THE PROVISION OF VENUE, HOTEL ACCOMMODATION, MEALS AND SNACKS FOR OFFICIAL USE DURING SANGGUNIANG BAYAN MEMBERS AND EXECUTIVE COMMITTEE MEMBERS YEAR-END ASSESSMENT.**

**WHEREAS**, in accordance with the provisions of the Local Government Code of 1991, it is imperative that no contract be executed by the local chief executive on behalf of the local government unit without prior authorization from the relevant sanggunian;

**WHEREAS**, entering into contract is necessary for the provision of venue, hotel accommodation, meals and snacks during the conduct of Sangguniang Bayan Members and Executive Committee Members Year-End Assessment on December 7-8, 2023 with a budget allocation of One Hundred Fifty Thousand Pesos (Php 150,000.00) only;

**WHEREAS**, the selected bidder must be engaged in the business of providing hotel accommodation, catering services, and related amenities suitable for gatherings such as assemblies, conferences, workshops, and various group activities and demonstrates willingness to extend their services and facilities to the Municipal Government of Pinamalayan;

**WHEREAS**, the Municipal Government of Pinamalayan and the Winning Bidder should be amenable with the terms and conditions set forth in the contract, copy of which shall form as integral part of this Resolution;

**NOW THEREFORE, BE IT RESOLVED** by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro to enter into Contract with the Winning Bidder for the provision of venue, accommodation and foods for official use during Sangguniang Bayan Members and Executive Committee Members Year-End Assessment.

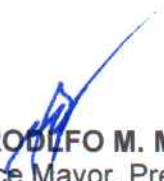
