RESOLUTION NO. 388-2023

RESOLUTION ADOPTING AND APPROVING THE DISASTER RISK REDUCTION AND MANAGEMENT IN HEALTH PLAN 2023-2025 OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS; Section 16 of RA 7160, otherwise known as Local Government Code of 1991, provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, xxx convenience of their inhabitants;

WHEREAS, Administrative Order No. 2020-0036 of Department of Health provides Guidelines on the Institutionalization of Disaster Risk Reduction and Management in Health (DRRM-H) in Province-wide and City-wide Health System;

WHEREAS, the Disaster Risk Reduction and Management in Health (DRRM-H) Plan 2023-2025 was formulated by the Local Health Board and was adopted through Resolution No. 02, series 2023 pursuant to RA No. 10121, the Philippine Disaster Risk Reduction and Management Act of 2010 and DILG and DOH Administrative Order on the directives of the formulation of DRRM-H Institutionalization to all LGUs and Government Hospitals;

WHEREAS, subject Local Health Board Resolution No. 02, s. 2023 was indorsed to the Sangguniang Bayan for review and appropriate action as provided in Section 114 of the Local Government Code of 1991;

WHEREAS, the DRRM-H Plan is an effective tool as an emergency response during calamities and emergencies situation as well as a guide in the provision of effective health services to the public.

NOW THEREFORE, BE IT RESOLVED by the 11th Sangguniang Bayan of Pinamalayan, Oriental Mindoro to adopt and approve the Disaster Risk Reduction and Management in Health Plan 2023-2025 of Pinamalayan, Oriental Mindoro.
