RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ARISTEO APASAN BALDOS, JR. TO ENTER INTO A CONTRACT OF SERVICE (COS) WITH MR. JOHN BENSON M. ORTEGA AS PROGRAMMER/TECHNICIAN II IN THE OFFICE OF THE MUNICIPAL VICE MAYOR OF THE MUNICIPAL GOVERNMENT OF PINAMALAYAN, ORIENTAL MINDORO.

WHEREAS, no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned pursuant to Local Government Code of 1991;

WHEREAS, the Municipal Government of Pinamalayan desires to avail the services of Mr. John Benson M. Ortega as Programmer/Technician II in the Office of the Municipal Vice Mayor;

WHEREAS, Mr. Ortega expresses his conformity to provide services needed by the local government unit and shall perform the functions as stipulated in the contract;

WHEREAS, Mr. Ortega shall render his service from January 01, 2024 to June 30, 2024 in consideration of a daily rate of Six Hundred Pesos (Php 600.00) only to be paid every 15th and 30th of the month;

WHEREAS, the Municipal Government of Pinamalayan and Mr. John Benson M. Ortega are amenable with the terms and conditions set forth in the contract, copy of which shall form as integral part of this Resolution.

NOW THEREFORE, BE IT RESOLVED by the 11th Sangguniang Bayan of Pinamalayan, Oriental Mindoro to authorize the Local Chief Executive, Hon. Aristeo Apasan Baldos, Jr. to enter into Contract of Service with Mr. John Benson M. Ortega as Programmer/Technician II in the Office of the Municipal Vice Mayor of the Municipal Government of Pinamalayan, Oriental Mindoro.
