ORDINANCE NO. 14-95

AN ORDINANCE REQUIRING BUILDING AND THE PREMISES THEREOF AND IDLE LOT/PIECE OF LAND ALONG STREETS IN THE POBLACION AND ALONG THE PROVINCIAL HIGHWAYS/ROADS WITHIN THE MUNICIPALITY BE KEPT AND MAINTAINED IN SANITARY CONDITION AND IMPOSE PENALTIES FOR ANY VIOLATION THEREOF.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro that -

Section 1. Buildings and the premises thereof and idle lot/piece of land along the streets of the poblacion and along the provincial roads/highways within the municipality be kept and maintained in in sanitary condition.


Section 2. Idle lot/piece of land along the streets in the poblacion and along the provincial roads/highways within the municipality may be converted into productive projects like gardens, nursery, and other worthwhile projects that will not cause pollution in the municipality.

Section 3. Owners may lend their lot/land left idle to a person or group of persons who will convert said lot/land into worthwhile and productive projects.

Section 4. Failure on the owner's part to comply with the requirements, the local government units shall have the work done and require the owner, administrator or tenant concerned to pay the expenses of the Local Government Unit.

Section 5. This Ordinance shall take effect fifteen (15) days after its approval.

Section 5. This Ordinance shall take effect fifteen (15) days after its approval.


