

ORDINANCE NO. 03-93

AN ORDINANCE DECLARING RECODO STREET AS ONE-WAY TRAFFIC AND LIMITING THE SPEED OF BUSES IN ENTERING RECODO STREET AND IMPOSING PENALTY IN VIOLATION THEREOF.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that :

Section I. Recodo Street is declared as one-way traffic from entering Madrid Boulevard passing said Street to Mabini Street;

Section II. The speed of buses and other public and/or private vehicles is limited to 15 kilometers per hour;

Section III. Drivers who violate this Ordinance shall be fined as follows :

- a) ₱200.00 for buses and trucks
- b) ₱100.00 for passenger jeepneys
- c) ₱ 50.00 for private vehicles and tricycles or imprisonment of one week, four (4) days and three(3) days, respectively or both fine and imprisonment at the discretion of the court,

Section IV. This Ordinance shall take effect immediately upon its approval.

Section VI. This Ordinance shall take effect ten (10) days after its approval.

Section V. If for some reason or reasons, any part or provision of this ordinance shall be held inconsistent with any ordinance, rules or regulations of the municipality they are repealed or modified accordingly.

Section IV. Any person who violates this ordinance shall be punished by a fine of two hundred pesos (P200.00) or imprisonment of not more than seven (7) days or both fine and imprisonment, at the discretion of the court.

Section III. It is likewise prohibited to any person to use any portion of the asphalted portion of public highways in barangays of this municipality.

Section II. No person shall use any portion of the public roads, park or square within the Poblacion area of Pinamulayan, Oriental Mindoro, for the drying of palay, corn or any other cereals, or for the drying of copra, firewood and other agricultural products or for any other purposes.

ORDINANCE NO. 06-93

AN ORDINANCE PROHIBITING THE USE OF PUBLIC ROADS, PARKS AND SQUARES FOR THE DRYING OF CEREALS, COPRA, FIREWOOD AND OTHER AGRICULTURAL PRODUCTS AND OTHER SIMILAR PURPOSES.

Be it ordained by the Sangguniang Bayan of Pinamalayan, Oriental Mindoro, that :

Section I. Definition of terms as used in this Ordinance.

a) Public roads - include national, provincial, municipal and barangay roads.

b) Park - a tract of land used by the public for recreation.

c) Squares - a figure of four square corner of roads, triangular shaped roads, T-roads and an angular shape of roads.

d) Cereals - include palay, corn, mungo, beans and the like.

e) Population - covers Zone I, Zone II, Zone III and Zone IV including Mawa Street, Del Pilar Street, Mabini Street and Madrid Boulevard.

Section II. No person shall use any portion of the public roads, park or square within the Population area of Pinamalayan, Oriental Mindoro, for the drying of palay, corn or any other cereals, or for the drying of copra, firewood and other agricultural products or for any other purposes.

Section III. It is likewise prohibited to any person to use any portion of the asphalted portion of public highways in barangays of this municipality.

Section IV. Any person who violates this ordinance shall be punished by a fine of two hundred pesos (P200.00) or imprisonment of not more than seven (7) days or both fine and imprisonment, at the discretion of the court.

Section V. If for some reason or reasons, any part or provision of this ordinance shall be held inconsistent with any ordinance, rules or regulations of the municipality they are repealed or modified accordingly.

Section VI. This ordinance shall take effect ten (10) days after its approval.
