Garbage Fee :

Section I. Owners of business establishments shall be charged garbage fees for the maintenance of garbage disposal.

Section II. Business establishments shall include eateries, theaters, rice mills, stores (sari-sari, drugstores, grocery, refreshments, etc.), welding shops, beauty parlors, barber shops, bakeries, hardware, lumber-yards, saw mills, ice plants, furniture shops, blacksmiths, etc.

Section III. The annual fees to be charged are as follows :

- a) Establishment paying a license fee of ₱1,000.00 and below shall be charged ₱ 50.00.
- b) Establishment paying a license fee of more than ₱1,000.00 shall be charged ~~5%~~ of license fee paid.

Section IV. Said fees shall be collected together with the license fees paid by establishment owners at the start of the fiscal year.

Section V. Violators of this ordinance shall be fined an amount of ₱ 200.00 and shall pay a surcharge of 25% per annum.

Section VI. This ordinance shall take effect on January 1, 1990.
